bizhub SECURE Alert by Konica Minolta provides essential MFP security for key industries

Nearly all multifunction printers (MFPs) have a fundamental security risk – organizations don’t know when a data or document breach occurs. Unauthorized MFP use by authorized users is a key source of data breaches: Organizations don't know who used the MFP for what and when.

This leaves these organizations potentially liable for the data breaches that occur at their MFPs. In addition, data breaches at the MFP may expose an organization’s important trade secrets and intellectual property information as well as customer, patient, and employee data and personally identifiable information (PII).

Konica Minolta MFPs don’t have this security risk. That’s because most Konica Minolta MFPs can optionally offer bizhub SECURE Alert as additional security protection.

bizhub SECURE Alert provides both information on who used the MFP for what and when as well as providing a user-configurable breach alert system. It is both low cost and easy to use.

MFP Activity Archive

- Full-text or keyword searchable archive of all MFP documents printed, copied, scanned, emailed, and faxed
- Document auto-archiving and categorizing of all MFP activities
- Searchable by day, time, device, user, and much more
- Audit trail of all MFP activity for compliance requirement

Breach Alert Notifications

- Key word and key data breach triggers; user-configurable
- Automatic email notification of breach alerts to user-designated personnel (such as a Compliance Officer)

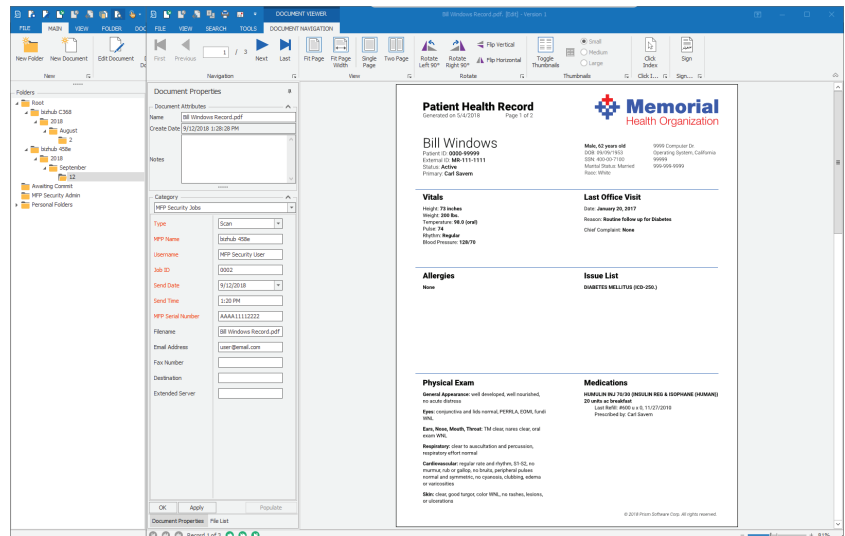
bizhub SECURE Alert by Konica Minolta is the industry's only low cost, all-inclusive way to notify organizations when they've had a MFP security breach due to unauthorized usage.

How it Works

bizhub SECURE Alert is powered by DocRecord, an application that automatically processes Konica Minolta MFP activity records. This MFP activity record, Image Log Transfer File (ILTF), is an inherent part of nearly all of Konica Minolta MFPs – both A3 and A4 models. The ILTF records all user MFP activity information: copies, prints, scans, emails, and faxes. The ILTF provides both a data file and a PDF of the document of this activity. This data set (activity data file and PDF) is then provided to DocRecord which OCRs (optical character recognition) the documents and then automatically categorizes and archives them.

DocRecord provides a full-management interface for bizhub SECURE Alert allowing the user to easily manage MFPs, key words and key data, breach alerts, and much more.

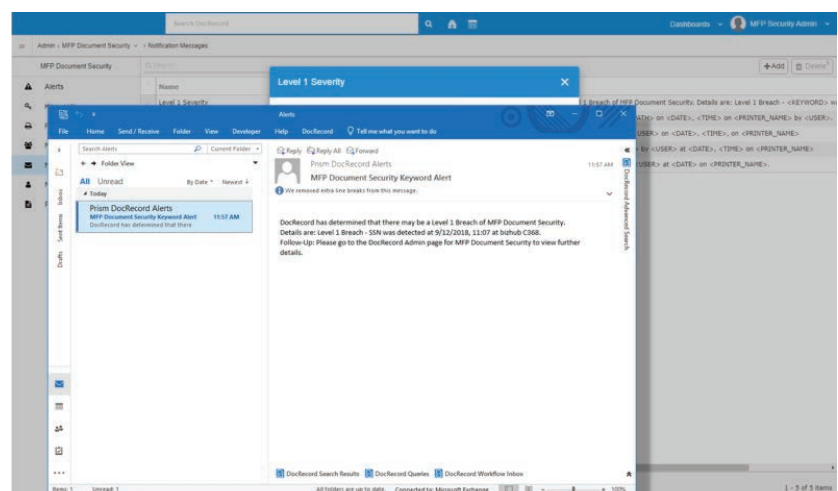
